GENERAL REGULATION PANORAMA MUN 2021

I. DELEGATIONS

Article 1:

Any representative of a delegation will be prohibited from leaving the committee during the sessions, unless it is about physiological needs or some consideration of the Chair.

Article 2:

The Observer Delegations, if one is present, may be present at the formal sessions of different bodies.

Article 3:

Delegates who:

- Failure to comply with the rules of behavior
- They do not carry the credential of the delegation to which they will be represented

II. COMMITTEES

Article 4:

Each committee will be governed according to the regulations established herein, as well as the authority of the Chair and the Secretariat.

Article 5:

Each committee will debate its pertinent topics.

III. SECRETARIAT

Article 6:

The Secretariat of this model United Nations will be the last instance for decision-making within it.

Article 7:

The Secretariat may establish oral or written statements to any committee of this Model United Nations.

Article 8:

The Secretariat will have the right in any committee to act as a member of the Chair when it deems it pertinent.

IV. AUTHORITIES OF EACH COMMITTEE

Article 10:

The Chair of each committee will be made up of:

- a) President
- b) Moderator
- c) Conference officers

Article 11:


The president of each committee will be in charge of doing the following:

- It will establish the opening and closing of each session
- It will guide the discussions in the sessions
- Verify compliance with the regulations as well as the monitoring of the protocol
- Grant the right to speak, ask questions and inform the committee decisions made.
- Will read and review the possible worksheets and resolution.
- He will be responsible for maintaining the proper order in his respective committee
- It will recommend the motions that it considers pertinent

It will decide:

 The time limit on the list of speakers, moderated debate and simple debate.







iv. The approval of any motion established by a delegate.

Article 12:

The responsibilities of the Moderator will be the following:

- Will replace the President in case of absence
- Be part of the approval of possible resolution sheets in which it evaluates and correct the projects so that they can be presented to the Chair.
- Advise on rules and protocol to the delegations that request it,
- If necessary, coordinate or moderate simple discussions by a period of time to be determined according to the situation.
- He will give the floor in an orderly manner at the moment of the moderated debate.

Article 13:

The conference officer will take care of the following:

- Assist the President and the Moderator in their functions during the development of the sessions.
- Will carry out the roll call at the beginning of each session
- Record the votes and reprimands of the delegations
- Facilitate communication between delegates through messages written by means of the application approved by the model, as long as the President authorizes them.

Article 14:

Process to approve worksheets:

- Receive and review the possible worksheets verifying that they comply the form and content requirements to be able to be presented.
- Determine the order in which the draft resolutions should be presented for debate.
- During the debate, the amendments and corrections that arise until a final version is obtained.



SIMPLE CAUCUS



The Debate will be the means of interaction for the delegations to address the issues on the Agenda. Simple Caucus must be governed by these Regulations, in an environment of respect, tolerance, equality, cooperation and good will; and in accordance with the principles of the Charter of the United Nations.

The purpose of the Debate will be the preparation of a Resolution relevant to the issue, which must be objective, comprehensive and applicable.

Article 16:

It will be the responsibility of the Model Authorities to guide impartially towards a debate that is carried out in a constructive manner.

Article 17:

The Debate may adopt two different modalities:

- Moderate caucus
- Simple caucus

Article 18:

Moderate caucus

- The moderated debate will be the means by which the President will guide the course of agreements.
- The moderated caucus will take place according to the guidelines of the protocol in its virtual version.
- The list will follow an order with a limited time to make use of the word.
- b) The moderated caucus will have a certain time, but at the end it may be extended by means of a procedural motion. It should be shorter than the previous one.



Article 19:

The simple caucus may be used to expedite the alliances or to propose a change in the debate.

The simple caucus will have a certain time, but at the end it may be extended, by means of a procedural motion. It should be shorter than the previous one.

Article 20:

Motions:

Any delegate may make use of Motions to request that a proposal be considered during the sessions, as long as the forum is open.

VII. BEHAVIOR REGULATIONS

Article 21:

The delegates may not eat food, drink alcoholic beverages or smoke during the sessions of the different committees.

Article 22:

Dress code

-Women:

The dress is formal, it can be a tailored suit, dress or skirt. Plunging necklines are strictly prohibited.

-Men:

The dress is formal, they must wear a tie and a jacket in discreet colors.

Note: The use of red, orange or yellow garments is highly restricted, since they are considered offensive colors for some nations.
